### Rules for the Enhanced Self-Health Management for Crew Members.

In addition to the Ministry of Health and Welfare Announcement of the "Self-Health Management Compliance Items and Notice" (<https://reurl.cc/WEnpWZ>) Wei-Shou-Ji No. 1100200031 March 1, 2021, you must abide by the orders as follows:

1. You shall undergo a polymerase chain reaction (PCR) test for COVID-19 (Need to take deep throat saliva or nasopharyngeal swab) on the 9th and 14th day following your return (the day following arrival counts as the first day).
2. During the enhanced self-health management, please record your temperature, health status, and daily activities twice a day (morning and evening) correctly. Please cooperate with caring and tracking measures issued by your airline company.
3. Do not engage in close proximity or group activities, such as dining together, parties, public gatherings or other similar activities.
4. Do not take public transportation. Do not visit crowded places where social distancing is difficult to maintain and close contact with random people is highly likely, such as weddings, bars, nightclubs, department stores, night markets, etc.
5. Wearing a face mask is mandatory when you go outside.
6. Record your daily activities and the names of people you come into contact with every day.
7. Avoid unnecessary outdoor activities and contact with random people.
8. You are allowed to perform duties for long-haul or same-day return flights. Those who need to perform duties for same-day return flights must complete the enhanced self-health management period for crew members.
9. If you have symptoms such as fever, cough or other discomfort, please put on a medical mask, report to your airline company immediately and contact with the local health authorities (or call the toll-free hotline 1922) to obtain instructions on seeking medical attention. Do not take public transportation when you go to the hospital. Moreover, you must immediately report to your airline company and temporarily discontinue your flight duties.
10. After you seek medical care, are tested for COVID-19 in the hospital, and return home, please stay at home and do not go outside before you receive your test results. If your test results come back positive, the local health authority will inform you and help you seek medical attention. You are still required to conduct the Enhanced Self-Health Management for Crew Members for 9 days even if you test results come back negative. If your symptoms become worse, please make sure to wear a medical mask, report to your airline company actively and contact local health authorities(or call the toll-free hotline 1922) to obtain instructions on seeking medical attention. Please do not use public transportation to go to the hospital.
11. Those who flout the enhanced self-health management regulations will violate Subparagraph 4, Paragraph 1, Article 58 of the Communicable Disease Control Act, and be fined ranging from NT\$100,000 to NT\$1,000,000.

- 九、如有發燒、咳嗽、腹瀉、嗅味覺異常或其他任何身體不適，請佩戴口罩，立即通報所屬航空公司，並主動與當地衛生局聯繫(或撥 1922)，依指示儘速就醫，且禁止搭乘大眾運輸工具就醫。此外，須主動通報所屬航空公司，暫停派飛。
- 十、如您就醫後，經醫院安排採檢，自採檢醫院返家後，於接獲通知檢驗結果前，應留在家中，不可外出，如檢驗結果陽性，衛生局將會通知您及安排就醫。另於獲知檢驗結果為陰性後，仍需完成加強版自主健康管理滿 9 天，期間如果症狀加劇，請確實佩戴好醫用口罩，並應主動通報所屬航空公司及與衛生單位聯繫(或撥 1922)，依指示儘速就醫，且禁止搭乘大眾運輸工具就醫。
- 十一、如未確實遵守各項加強版自主健康管理規定，係違反傳染病防治法第 58 條第 1 項第 4 款規定，可裁處新臺幣 10 萬元以上 100 萬元以下罰鍰。

### Rules for the Enhanced Self-Health Management for Crew Members.

In addition to the Ministry of Health and Welfare Announcement of the "Self-Health Management Compliance Items and Notice" (<https://reurl.cc/WEnpWZ>) Wei-Shou-Ji No. 1100200031 March 1, 2021, you must abide by the orders as follows:

1. You shall undergo a polymerase chain reaction (PCR) test for COVID-19 (Need to take deep throat saliva or nasopharyngeal swab) on the 9th and 14th day following your return (the day following arrival counts as the first day).
2. During the enhanced self-health management, please record your temperature, health status, and daily activities twice a day (morning and evening) correctly. Please cooperate with caring and tracking measures issued by your airline company.
3. Do not engage in close proximity or group activities, such as dining together, parties, public gatherings or other similar activities.
4. Do not take public transportation. Do not visit crowded places where social distancing is difficult to maintain and close contact with random people is highly likely, such as weddings, bars, nightclubs, department stores, night markets, etc.
5. Wearing a face mask is mandatory when you go outside.
6. Record your daily activities and the names of people you come into contact with every day.
7. Avoid unnecessary outdoor activities and contact with random people.
8. You are allowed to perform duties for long-haul or same-day return flights. Those who need to perform duties for same-day return flights must complete the enhanced self-health management period for crew members.
9. If you have symptoms such as fever, cough or other discomfort, please put on a medical mask, report to your airline company immediately and contact with the local health authorities (or call the toll-free hotline 1922) to obtain instructions on seeking medical attention. Do not take public transportation when you go to the hospital. Moreover, you must immediately report to your airline company and temporarily discontinue your flight duties.
10. After you seek medical care, are tested for COVID-19 in the hospital, and return home, please stay at home and do not go outside before you receive your test results. If your test results come back positive, the local health authority will inform you and help you seek medical attention. You are still required to conduct the Enhanced Self-Health Management for Crew Members for 9 days even if you test results come back negative. If your symptoms become worse, please make sure to wear a medical mask, report to your airline company actively and contact local health authorities(or call the toll-free hotline 1922) to obtain instructions on seeking medical attention. Please do not use public transportation to go to the hospital.
11. Those who flout the enhanced self-health management regulations will violate Subparagraph 4, Paragraph 1, Article 58 of the Communicable Disease Control Act, and be fined ranging from NT\$100,000 to NT\$1,000,000.
